2. Type and Scope of Data Processing (Including Legal Basis and Storage Period)

As part of your application for a workshop grant, subject to your consent, personal data will be processed in accordance with Article 4, No. 1, GDPR (first and last name, contact details, curriculum vitae and letter of motivation). The documents received by e-mail or post will be processed by authorized IHE employees based on objective criteria for the purpose of checking whether the IHE recommends funding. The documents will not be forwarded. You can present the letter of recommendation handed out at the end, if applicable, directly to the respective sponsor. The final decision on financial support and the processing of the financial support is made without involving the KIT and solely by the respective sponsor.

The legal basis for processing your data is your consent according to Article 6, par. 1, cl. 1 (a), GDPR. Your consent is voluntary. Refusal or withdrawal of your consent will not result in any drawbacks. The consent may be withdrawn in writing anytime with effect for the future. For the withdrawal of your consent in writing, use the following address: info@ihe.kit.edu.

Your data will only be stored at the KIT for as long as is necessary to fulfill the respective purpose (deletion at the latest after the ESoA course “All Digital Radar System Engineering”). If you revoke your consent, your data will be deleted immediately after receipt of the revocation.

3. Your Rights

You have the right to withdraw your consent to the processing of your data according to Article 7, par. 3, GDPR anytime with effect for the future. The withdrawal may also refer to certain parts of your consent.

In addition, you have the following rights as far as your personal data are concerned:

- Right to confirmation as to whether data about you are processed and right to information about the data processed and to further information about data processing as well as right to obtain copies of the data (Article 15, GDPR)
- Right to rectification or completion of incorrect or incomplete data (Article 16, GDPR)
- Right to immediate erasure of your personal data (Article 17, GDPR)
- Right to restriction of processing (Article 18, GDPR)

In addition, you have the right to complain about the processing of your personal data by Karlsruhe Institute of Technology (KIT) with its supervisory authority (Article 77, GDPR).
